Our responsibility is to conduct an audit in accordance with guidance issued by the Audit Commission and, on the basis of our review of the annual return and supporting information, to report whether any matters that come to our attention give cause for concern that relevant legislation and regulatory requirements have not been met.

### External auditor's report

Except for the matters reported below, on the basis of our review, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The Council failed to approve Section 2 of the Annual Return (the Annual Governance Statement) by 30 June 2014, the date required by the Accounts and Audit (England) Regulations 2011.

Other matters not affecting our opinion which we draw to the attention of the council:

Please ensure that the Annual Return is accurately completed before submission for audit. It was necessary for us to send the Annual Return back for the following amendments to be made to the figures in Section 1 for the year ended 31 March 2014:

- Box 2 restated to £4,000 - to exclude the council tax support grant (CTSG) of £296 received in the year.
- Box 3 restated to £1,257 - to include the CTSG of £296, together with a VAT refund (£656) and receipt of contribution towards traffic sensor (£305), both of which had initially been shown as deductions from expenditure.
- Box 6 restated to £3,708 - to exclude the VAT refund (£656) and receipt of contribution towards the traffic sensor (£305).
- Box 9 restated to £4,119 - to include the Council's share of the traffic sensor
